Brown, Chakravarthi Advance in Qualifying Draw

Two incoming freshman for the University of Illinois Men's Tennis Program made successful debuts at the Atkins Tennis Center Saturday, advancing to the 2nd round of qualifying at the JSM Futures of Champaign-Urbana. Alexander Brown and Caleb Chakravarthi both picked up victories on their future home courts, and are two wins away from the tournament's main draw. Brown needed three sets to get past Perry Gregg, 3-6, 7-6 (1), 6-2, while Chakravarthi had an easier day, 6-1, 6-2 over John Kidd

Two of their future teammates were not as successful. Vuk Budic fell in straight sets to American Josh Silverstein, while Pablo Landa was unable to participate this morning, and was a walkover loser in a match with Grant Bond.

The second round of qualifying begins tomorrow morning at 10AM. Top seed Alexios Halebian begins his run after receiving a bye in the first round. He'll take on Jason Seidman. The future Illini will both be featured tomorrow on North court 1, with Chakravarthi battling South African Damon Gooch at 10AM, and Brown facing Rowland Phillips immediately following. Admission is free for the entirety of the tournament.
